# PUBLIC SAFETY FACILITY COMMITTEE AUGUST 24, 2021 RESOURCE ROOM, TOWN HALL

## **CALL TO ORDER**

Chair R. Weatherall called the meeting to order at 7:09 p.m. Attending were L. Alexson, T. Jones, H. Schwartz, D. Morris, Acting Fire Chief L. Prentiss, R. Donahue, P. Dziadose, and J. Emerson. Absent: Chief P. Nikas, J. Fay, R. Harb, K. Carlson, and C. Surpitski.

#### CITIZEN QUERIES

Bob welcomed two gentlemen from the community. Ken Swenson, Linebrook Road, suggested comparing our town project with those of the towns around Ipswich. Also, discussion of the question "What if we don't do this?" to the residents. There is a lot more than the well-being and comfort of these people who occupy these spaces currently. He was invited to speak at Town Meeting by Bob, Harvey, and Linda. Bob educated Ken re the comparison sheet of like situations with public safety in neighboring towns which Chief Nikas had put together.

John Sarni, Little Neck, spoke to his reasons for coming. While he supports the retention of the current fire facility, he wondered where the money would come from to support restoration/change and is interested in being on the committee to work on the old fire station. He was assured by several members that people in town look kindly on restoration projects.

Bob announced that the Warrant for the October 16 Special Town Meeting has been presented by the Select Board to take place on the High School football field. Very valuable fact sheets are out.
