



## TOWN OF IPSWICH MASSACHUSETTS

### TRAFFIC RULES AND REGULATIONS

December 05, 1985  
(Amended through January 1<sup>st</sup>, 2021)

The Board of Selectmen of the Town of Ipswich, acting by virtue of the power given to it by Section 22 of Chapter 40 of the General Laws of Massachusetts, and by virtue of any other power hereto enabling, hereby adopts Rules and Regulations governing the use of vehicles and carriages upon the streets and highways of said town which are hereto annexed, the same to be known as Traffic Rules and Regulations of the Town of Ipswich. All Traffic Rules and Regulations in force in the Town of Ipswich when these Rules and Regulations take effect, consistent with the provisions of these Rules and Regulations, shall be deemed to be a continuation thereof.

**ARTICLE I**

**DEFINITIONS**

For the purpose of these rules and regulations, the words and phrases used herein shall have the following meaning, except in those instances where the context clearly indicates a different meaning.

- (a) Street or Highway The entire width between property lines of every way open to the use of the public for purposes of travel.
- (b) Roadway That portion of a street or highway between the regularly established curb lines or that part, exclusive of shoulders, improved and intended to be used for vehicular traffic.
- (c) Lane A longitudinal division of a roadway into a strip of sufficient width to accommodate the passage of a single line of vehicles.
- (d) Vehicle Every device in, upon or by which any person or property is or may be transported or drawn upon a street or highway, except devices moved by human power or used exclusively upon stationary rails or tracks.
- (e) Emergency Vehicle Vehicles of the Fire Department, police vehicles, ambulances, and emergency vehicles of federal, state, and municipal departments or public service corporations when the latter are responding to an emergency in relation to the Police or Fire Department.
- (f) Parking The standing of a vehicle, whether occupied or not, otherwise than temporarily for the purpose of, and while actually engaged in loading or unloading, or in obedience to an officer or traffic signs or signals, or while making emergency repairs, or, if disabled, while arrangements are being made to move such vehicle.
- (g) Pedestrian Any person afoot or riding on a conveyance moved by human power, except upon a bicycle or tricycle.
- (h) Sidewalk That portion of a street or highway set aside for pedestrian travel.
- (i) Crosswalk That portion of a roadway ordinarily included within the connection of curb lines or property lines at intersections, or at any portion of a roadway clearly indicated for pedestrian crossing by lines on the road surface or by other markings or signs.
- (j) Railroad Crossing Any intersection of ways at grade with a railroad right of way.
- (k) Traffic Control Area Any area along any way, other than an intersecting way, at which drivers are to be controlled by traffic control signals.
- (l) Traffic Island Any area or space set aside within a roadway which is not intended for use by vehicular traffic.
- (m) Safety Zone Any area or space set aside within a roadway for the exclusive use of pedestrians and which has been indicated by signs, lines or markings, having the written approval of the Department of Public Works, Commonwealth of Massachusetts.
- (n) Traffic Pedestrians, ridden or herded animals, vehicles, street cars or other conveyances either singly or together, while using any street or highway for the purpose of travel.

- (o) Official Traffic Signs All signs, markings and devices other than signals, not inconsistent with these rules and regulations, which conform to the standards prescribed by the Department of Public Works of the Commonwealth of Massachusetts and which have been placed or erected by authority of a public body or official having jurisdiction for the purpose of guiding, directing, warning or regulating traffic.
- (p) Official Traffic Signals All signals, conforming to the standards as prescribed by the Department of Public Works of the Commonwealth of Massachusetts, not inconsistent with these rules and regulations, placed or erected by authority of a public body or official having jurisdiction for the purpose of guiding, directing, warning or regulating traffic.
- (q) Traffic Control Signal Any device using colored lights which conforms to the standards as prescribed by the Department of Public Works of the Commonwealth of Massachusetts, whether manually, electrically, or mechanically operated, by which traffic may be alternately directed to stop and to proceed.
- (r) Officer For the purpose of these rules and regulations, an officer shall be construed to mean any police officer, constable, or special officer, provided a badge of office is displayed upon his/her outer coat or garment.
- (s) Bus Stop An area in the roadway set aside for the boarding of or alighting from, and the parking of, busses.
- (t) Taxicab Stands An area in the roadway in which certain taxicabs are required to park while awaiting to be engaged.
- (u) Service Zone An area in the roadway set aside for the accommodation of commercial and transient vehicular traffic.
- (v) Funeral Any procession of mourners, properly identified as such, accompanying the remains of a human body.
- (w) Official Street Marking Any painted line, legend, marking or marker of any description painted or placed upon any way which purports to direct or regulate traffic and which has been authorized by the Board of Selectmen and which has the written approval of the Department of Public Works, Commonwealth of Massachusetts.
- (x) Rotary Traffic The counter-clockwise operation of a vehicle around a structure or object.
- (y) U-Turn The turning of a vehicle by means of a continuous left turn whereby the direction of such vehicle is reversed.
- (z) Commercial Vehicle Any vehicle being used in the transportation of goods, wares or merchandise for commercial purposes.
- (a.1) Commercial Vehicle/Heavy Any commercial vehicle of two and one-half (2 1/2) tons or in excess of two and one-half (2 1/2) tons, tare weight.
- (b.1) Bridge Applies to any structure, whether single or multiple span construction, that spans a body of water, depression, highway, or railway, and affords passage for pedestrians or vehicles of all kinds of any combination thereof of twenty feet or more.

## **ARTICLE II**

### **AUTHORITY AND DUTIES OF POLICE**

#### **Section 1. Police to Direct Traffic**

It shall be the duty of officers designated by the Chief of Police to enforce the provisions of these rules and regulations. Such officers are hereby authorized to direct all traffic, either in person or by means of visible or audible signal in the conformance with the provisions of these rules and regulations, provided that in the event of a fire or other emergency in order to expedite traffic or safeguard pedestrians, officers of the Police and Fire Departments may direct traffic, as conditions may require, notwithstanding the provisions of these rules and regulations.

#### **Section 2. Police May Close Streets Temporarily**

The Chief of Police, or acting Chief of Police, is hereby authorized to close temporarily any street or highway in an impending or existing emergency or for any lawful assemblage, demonstration or procession, provided there is reasonable justification for the closing of such street.

#### **Section 3. Police May Prohibit Parking Temporarily**

The Chief of Police, or acting Chief of Police, is hereby authorized to prohibit, temporarily, parking on any street or highway, or part thereof in an impending or existing emergency, or for a lawful assemblage, demonstration or procession, provided there is reasonable justification for such prohibition. Vehicles parked in places where parking is prohibited temporarily may be moved by or under the direction of an officer.

#### **Section 4. Exemptions**

The provisions of these rules and regulations shall not apply to drivers actually engaged in work upon a street or highway closed to travel or under construction or repair, to officers when engaged in the performance of public duties, nor to drivers of emergency vehicles while operating in an emergency and in performance of public duties when the nature of the work of any of these circumstances necessitates a departure from any part of these rules and regulations. These exceptions shall not, however, protect the driver of a vehicle from the consequence of a reckless disregard of the safety of others.

**ARTICLE III**

**TRAFFIC SIGNS, SIGNALS, MARKINGS AND ZONES**

**Section 1. Traffic Signs and Signals**

- (a) The Director of Public Works is hereby authorized and, as to those signs and signals required hereunder, it shall be his duty to place and maintain, or cause to be placed or maintained, all official traffic signs, signals, markings and safety zones. All signs, signals, markings and safety zones shall conform to the standards as prescribed by the Department of Public Works of the Commonwealth of Massachusetts.
- (b) Section 2. and 3. of ARTICLE II, subsections (j) and (l) of Section 1., and Sections 2. to 5. inclusive of ARTICLE V relating to parking shall be effective only during such time as official signs are erected and maintained in each area designating the provisions of such sections and are located so as to be easily visible to approaching drivers.
- (c) Sections relating to one-way streets shall be effective only during such time as a sufficient number of official signs are erected and maintained at each of the exits for each one-way street, so that at least one sign shall be clearly visible for a distance of at least seventy-five (75) feet to drivers approaching such an exit.
- (d) On any street where spaces have been marked for the parking of vehicles by lines painted on the surface of the roadway, it shall be unlawful for any driver to park a vehicle unless it is wholly within the painted white lines.

**Section 2. Display of Unauthorized Signs, Signals, and Markings Prohibited**

No person or corporation shall place, maintain or display upon or in view of any street, any unofficial device, sign, signal, curb marking or street marking which purports to be or is an imitation of or resembles an official traffic device, sign, signal, curb marking, or street marking, or which attempts to direct the movements of traffic, or which hides from view any official sign, signal marking or device. The Chief of Police, or acting Chief of Police, is hereby empowered to remove every such prohibited sign, signal, marking or device, or cause it to be removed, without notice.

**Section 3. Obedience to Traffic Signs, Signals and Markings**

No driver of any vehicle shall disobey the instructions of any official traffic control signal, sign, marking or legend unless otherwise directed by a police officer.

**Section 4. Interference with Signs, Sign Legend, Markings Prohibited**

No person who willfully defaces, injures, moves, obstructs, or interferes with any official traffic sign, signal, or marking shall be liable to a penalty not exceeding fifty dollars (\$50) for each and every offense.

**Section 5. Location of Bus Stops, Taxicab Stands and Service Zones**

The location of all bus stops, taxicab stands and service zones shall be specified by the Board of Selectmen and, in the case of taxicab stands, the Chief of Police, with the approval of the Board of Selectmen, shall designate who may use them as such.

**Section 6. Location of Traffic Islands**

Pursuant to the provisions of Massachusetts General Laws Chapter 85, Section 2, traffic safety islands shall be installed and maintained at the following locations:

- (a) North Main Street at High Street and East Street
- (b) Market Street at Market Square
- (c) East Street at County Street
- (d) East Street at Spring Street and County Street
- (e) Northgate Road at Argilla Road
- (f) Washington Street and Market Street at Topsfield Road
- (g) High Street at Linebrook Road in Lord Square

**Section 7. Special School Speed Zones**

Pursuant to Massachusetts General Laws, Chapter 90, Section 17, special school speed zones shall be installed and maintained in the following areas:

- (a) Doyon School Linebrook Road [10/2/97]
- (b) Speeds on the following school properties shall be limited to fifteen (15) miles per hour:
  - (1) School Street from the northerly entrance at High Street to the southerly entrance at the south boundary of the Middle School/High School property
  - (2) Middle School/High School access roads and parking
  - (3) Winthrop School driveway and parking lots
  - (4) Doyon School driveway and parking lots
  - (5) Mile Lane field parking lot

[Section (b) adopted effective 9/13/01]

**Section 8. Safety Zones**

Pursuant to Massachusetts General laws, Chapter 90, Section 18B, establishment of designated safety zones shall be installed and maintained in the following areas:



- (a) Linebrook Road - beginning at its intersection with Lord Square (railroad crossing) westerly for a distance of one thousand, five hundred (1,500) feet. [12/21/20].

**ARTICLE IV**

**ZONES OF QUIET**

The Director of Public Works may temporarily establish a zone of quiet upon any street where a person is seriously ill. Said temporary zone of quiet may embrace all territory within a radius of two hundred (200) feet of the building occupied by the sick person. Said temporary zones of quiet shall be designated by the Director of Public Works by placing at a conspicuous place in the street a sign or marker bearing the words "Zone of Quiet".

**ARTICLE V**

**STOPPING, STANDING, PARKING**

**Section 1. General Prohibitions**

No person shall allow, permit or suffer any vehicle registered in his/her name to stand or park in any street, way, highway, road, or parkway under the control of the Town of Ipswich in violation of any of the Traffic Rules and Regulations adopted by the Board of Selectmen, and in particular in any of the following places, except when necessary to avoid conflict with other traffic or in compliance with the direction of a police officer or traffic sign or signal. Vehicles found violating any of the provisions of this Section may be moved by or under the direction of an officer and at the expense of the owner:

- (a) Within an intersection;
- (b) Upon any sidewalk;
- (c) Upon any crosswalk;
- (d) Upon the roadway in a rural or sparsely settled district;
- (e) Upon a roadway in a business or industrial zone where parking is permitted unless both wheels on the right side of the vehicle are within twelve (12) inches of the curb or edge of the roadway, except upon those streets which are designated as one-way streets. On such one-way streets, vehicles shall be parked in the direction in which said vehicle is moving and with both wheels within twelve (12) inches of the curb. These restrictions shall not apply to streets or parts of streets where angle parking is required by these regulations;
- (f) Upon any roadway where the parking of a vehicle will not leave a clear and unobstructed lane at least ten (10) feet wide for passing traffic;
- (g) Upon any street or highway within ten (10) feet of a fire hydrant;
- (h) In front of any private road or driveway;
- (i) Upon any street or highway within twenty (20) feet of an intersecting way, except an alley;
- (j) No driver of a vehicle shall stop or stand his/her vehicle on the same side of the street within twenty (20) feet of the front wall of a fire station, nor within seventy-five (75) feet of a straight line extending at right angles across the street from the center of the front line of the lot on which a fire station is located, except to let off or take on passengers or to receive or deliver goods or merchandise, provided signs are erected acquainting the driver of such restrictions; [Amended May 15, 1986]
- (k) Alongside or opposite any street excavation or obstruction when such stopping, standing or parking would obstruct traffic;
- (l) Within twenty-five (25) feet of the nearest rail of a railroad crossing when there are no gates at such crossing; otherwise within five (5) feet from the gate;
- (m) On a bridge or the approach thereto;

- (n) If such vehicle, registered in the name of a person who is not an Ipswich resident or in the name of a business the principal place of which, and the registration address of which, is not located in Ipswich. [Added 4/13/98]

### **Section 2. Service Zones**

No person shall park a vehicle upon any street in any service zone for a period of time longer than thirty (30) minutes and except while actually engaged in loading or unloading.

- (a) South Main Street - westerly side beginning at a point sixty-five (65) feet northerly of a point opposite the northeasterly corner of its intersection with Elm Street, thence northerly for a distance of twenty-two (22) feet. [Added 4/16/91]
- (b) Town Wharf - southeasterly side beginning at a point one hundred forty-two (142) feet easterly of its intersection with Water Street, and thence easterly for a distance of twenty-five (25) feet. [Added 8/15/94]
- (c) Jeffrey's Neck Road - northeasterly side beginning sixty (60) feet easterly of pole number six (6) and thence easterly for a distance of forty (40) feet. [Added 8/30/01]
- (d) Estes Street – westerly side, beginning at a point twenty-two (22) feet south of Saltonstall Street, for a distance of fifty-six (56) feet [Added 5/13/04]
- (e) Wildes Court – southerly side for its entire length [Added 4/26/07]

### **Section 3. Angle Parking**

Upon the following streets or parts of streets which have been marked or signed for angle parking, vehicles shall be parked with one wheel within twelve (12) inches of the curb and at the angle to the curb indicated by marks or official signs. The vehicles shall be parked wholly within the painted lines provided.

- (a) Market Street - westerly side from Market Square southerly for a distance of one hundred twelve (112) feet, not including the first forty-three (43) feet due to the corner and the fire hydrant. [Amended 4/13/98]
- (b) Depot Square - northerly side from Market Street westerly for a distance of one hundred thirty-four (134) feet, with the exception of the first thirty (30) feet due to the intersection and a fire hydrant.
- (c) On the northerly end of the Town Green opposite #19 North Main Street, for a distance of thirty (30) feet.
- (d) North Main Street (easterly branch) - easterly side, beginning at a point four hundred twenty-eight (428) feet north of the intersection of South Main Street, thence northerly for a distance of one hundred fifty (150) feet. [Added 11/13/88]
- (e) North Main Street (westerly branch) - beginning at a point four hundred thirty-four (434) feet north of the intersection of Central Street, thence northerly for a distance of sixty-seven (67) feet [Added 12/5/85]

- (f) Town Wharf southeasterly side, beginning at a point one hundred ten (110) feet easterly of its intersection with Water Street, and thence easterly to its intersection with Agawam Avenue, a distance of four hundred eight (408) feet. [Added 8/15/94]

**Section 4. Parking Prohibited on Certain Streets**

Upon the following streets or highways or parts thereof, parking is hereby prohibited:

- (a) County Street - southerly side, from Poplar Street to Green Street
- (b) Green Street - northerly side, from Meetinghouse Green to Turkey Shore Road
- (c) East Street - southerly side, Wilcombs Square easterly one hundred ten (110) feet to the driveway of #27 East Street
- (d) South Main Street - easterly side, from a point ninety-five (95) feet south of the intersection of Elm Street, thence southerly for a distance of six hundred fifty (650) feet
- (e) Mount Pleasant Avenue - southerly side, from Washington Street to a point opposite Burleigh Avenue
- (f) Wayne Avenue - southerly side, from Topsfield Road westerly to its terminus with Putnam Road [amended 11/7/02]
- (g) Wayne Avenue - southerly side, from Topsfield Road westerly for a distance of one hundred sixty (160) feet
- (h) Summer Street - westerly side, from North Main Street to its terminus at Water Street.[Adopted 8/18/14]
- (i) Water Street - southeasterly side, from Green Street to the Town Wharf
- (j) [Deleted 5/13/04]
- (k) Estes Street - westerly side, beginning at a point seventy-eight (78) feet south of Saltonstall Street, thence southerly to Peatfield Street [Amended 5/13/04]
- (l) Saltonstall Street - southerly side, from Estes Street easterly for a distance of ninety-six (96) feet to the easterly line of Union Street
- (m) Hammatt Street - easterly side, from a point one hundred eighteen (118) feet northerly of the intersection of Hammatt Street and Depot Square, thence northerly for a distance of forty (40) feet
- (n) North Main Street (easterly branch) - easterly side, beginning at the intersection of South Main Street, thence northerly for a distance of two hundred eighty-eight (288) feet [Amended 4/13/98]
- (o) Elm Street - southerly side, from County Street westerly for a distance of two hundred thirty (230) feet
- (p) Kimball Street - easterly side, for a distance of one hundred twenty-eight (128) feet between Peatfield Street and First Street
- (q) County Street - westerly side, from Elm Street to a point sixty (60) feet north of the intersection of County Street and Poplar Street
- (r) North Main Street (westerly branch) - southeasterly side, from a point two hundred fifty-four (254) feet south of Warren Street thence southerly for a distance of two hundred eighty (280) feet
- (s) North Ridge Road - northerly side, from Duck Way to Falcon Way

- (t) Kimball Avenue - easterly side, for a distance of eight hundred eighty-five (885) feet [11/13/00]
- (u) County Street - northwesterly side, from Wilcombs Square to Green Street
- (v) South Main Street - westerly side, beginning at a point four hundred forty-seven (447) feet south of the Choate Bridge, thence southerly for a distance of seven hundred twenty-five (725) feet
- (w) Manning Street - easterly side, from Central Street to High Street
- (x) Warren Street - northerly side, from North Main Street westerly for a distance of eighty-five (85) feet
- (y) Warren Street - southerly side, from North Main Street westerly for a distance of eighty-five (85) feet
- (z) Turkey Shore Road - easterly side, from Poplar Street to Woods Lane
- (a.1) Poplar Street - northerly side, from Turkey Shore Road to Woods Lane
- (b.1) Argilla Road - northerly side, beginning at the northeasterly boundary line as laid out by the County Commissioners December 20, 1921, at a point about ninety (90) feet westerly of the gate house entrance of the Trustees of Reservations to Crane Beach and running in a westerly direction to North Gate Road
- (c.1) Argilla Road - southerly side, beginning at the northeasterly boundary line as laid out by the County Commissioners December 20, 1921, at a point about ninety (90) feet westerly of the gate house entrance of the Trustees of Reservations to Crane Beach and running in a westerly direction to North Gate Road
- (d.1) Deleted [11/7/11]
- (e.1) Linden Street - westerly side, from the intersection of Ward Street northerly for a distance of two hundred (200) feet
- (f.1) East Street - northerly side, from the westerly entrance to the Town Wharf, thence easterly to the intersection of East Street and Jeffreys Neck Road, during the period may 15th through Labor Day of each year.
- (g.1) Bayview Road - easterly side, from the intersection of Clark Road to Plover Hill Road
- (h.1) Bayview Road - westerly side, from a point opposite the intersection of Clark Road to Plover Hill Road
- (i.1) Newmarch Street - northerly side, from Jeffreys Neck Road to the easterly end of Newmarch Street
- (j.1) Newmarch Street - southerly side, from Jeffreys Neck Road to the easterly end of Newmarch Street
- (k.1) North Main Street - easterly side, a distance of twenty (20) feet, situate opposite the main entrance to the United Methodist Church
- (l.1) North Main Street - southerly side of the island west of the United Methodist Church
- (m.1) Topsfield Road - northerly side, as signed, from pole #4/150 to pole #4/144
- (n.1) Topsfield Road - southerly side, from the intersection of Willowdale Road to the easterly edge of the drive of land now or formerly of Foote, a distance of four hundred (400) feet

- (j) Parking on Colonial Drive, westerly side, for a length of sixty (60) feet southward from the terminus of the southernmost handicapped parking sign, shall be limited to users of

the Shady Creek conservation Area from dawn to dusk; said users shall not park a vehicle therein for a period of time longer than two (2) hours [Adopted effective 6/21/07]

- (k) No person shall park a vehicle for a period of time longer than one (1) hour between the hours of 9am and 6pm, of any day, on the following streets or parts there of:
  - Elm Street - Southerly side beginning at the intersection of South Main Street, thence easterly for a distance of 60 feet. [Adopted Effective 09/20/2010 and 11/29/2010]

**Section 6. Restricted All-Night Parking**

- (c) No person shall park a vehicle between the hours of 2:00 A.M. and 6:00 A.M. in the following location(s) [Adopted 9/11/95]:

  - (2) South Main Street, easterly side, from County Street to Market Square
  - (3) Market Street, northwesterly side, from Market Square to Depot Square

  - (6) Central Street, southerly side, from Market Square to Lord Square
  - (7) Depot Square
  - (8) Lord Square

**Section 7. Parking Permitted By Those Who Are Handicapped Only**

No person shall allow, permit, or suffer any vehicle registered in his name to stand or park in any space designated by these Traffic Rules and Regulations as a Handicapped Parking Space unless said vehicle displays a valid "handicapped" vehicle registration plate or placard. The following spaces are designated as handicapped parking spaces:

- (e) Topsfield Road off street parking lot - two angle parking spaces adjacent to the handicapped ramp, as designated by signs [11/13/86]

No person shall allow, permit, or suffer any vehicle registered in his name to stand or park in any space designated by these Traffic Rules and Regulations as a Handicapped Parking Space during certain designated hours unless said vehicle displays a valid "handicapped" vehicle registration plate or placard.

**Section 9. Parking Restricted in the Municipal Parking Lot Off Topsfield Road (Commonly referred to as the Commuter Rail Lot)**

- (a) No person shall park a truck, tractor, or tractor-trailer combination in the municipal lot off Topsfield Road unless said truck, tractor, or tractor-trailer combination is in the northeasterly corner of said lot in an area signed as designated for truck parking only
- (b) No truck, tractor, or tractor-trailer combination shall be left unattended in said municipal parking lot with its engine or refrigeration unit or any other auxiliary motor running.
- (c) No truck, tractor, or tractor-trailer combination shall park in said municipal parking lot in excess of twenty -four (24) hours unless Sundays or holidays intervene
- (d) No person shall allow, permit, or suffer any vehicle registered in his name to stand or park on the southerly access corridor from Peatfield Street, beginning at the southeast corner at Peatfield Street thence northerly for a distance of twenty-five (25) feet [1/15/88]
- (e) Parking shall be prohibited along the access to the municipal parking lot easterly along the southerly fence line of land from EBSCO for a distance of forty-four (44) feet and southerly along the westerly fence line of said land of EBSCO for a distance of sixty-seven (67) feet [Added 5/5/88-relettered]
- (f) No person shall park a vehicle other than a truck, tractor, or tractor/trailer combination in the Municipal Lot off Topsfield Road unless said vehicle is parked within the lines of a designated Parking Space [Amended 1/3/89]
- (g) Between the hours of 6:00 a.m. and 6:00 p.m. Monday through Friday, no person shall park a vehicle in the Municipal Parking Lot off Topsfield Road unless the vehicle is

registered in the name of an Ipswich resident or is registered in the name of a business, the principal address of which and the registration address of which are located in Ipswich, as evidenced by display upon the vehicle of a Solid Waste Transfer Station sticker or a Crane Beach sticker issued by the Town of Ipswich. This subsection shall not apply to any vehicle displaying a handicapped registration plate or dashboard placard, which is parked within an officially designated handicapped parking space.[Adopted 4/13/98][Amended 5/18/98][Amended 07/15/19]

**Section 10. Parking of Vehicles with Attached Trailers and Parking of Detached Trailers Prohibited on Certain Streets**

Upon the following streets or highways or parts thereof, parking of a motor vehicle with an attached boat trailer and/or the parking of a detached trailer is prohibited:

- (a) Hovey Street - easterly side from East Street southerly to Water Street [5/17/90]
- (b) Hovey Street - westerly side from East Street southerly to Water Street [5/17/90]
- (c) Scottons Lane - easterly side from East Street southerly to Water Street [5/17/90]
- (d) Scottons Lane - westerly side from East Street southerly to Water Street [5/17/90]
- (e) Wainwright Street - easterly side from East Street to its terminus [5/17/90]
- (f) Wainwright Street - westerly side from East Street to its terminus [5/17/90]
- (g) Sawyer Street - northerly side from Wainwright Street to Cogswell Street [5/17/90]
- (h) Sawyer Street - southerly side from Wainwright Street to Cogswell Street [5/17/90]
- (i) Cogswell Street - easterly side from East Street northerly to its terminus [5/17/90]
- (j) Cogswell Street - westerly side from East Street northerly to its terminus [5/17/90]
- (k) Summer Street - easterly side from North Main Street to Water Street [5/17/90]
- (l) Summer Street - westerly side from County Street to Water Street [5/17/90]
- (m) Water Street – Northwesterly side, from its intersection with the Town Wharf entrance and thence westerly for a distance of 807 feet to Scotton’s Lane.[10/16/15]

**Section 11. Eagle Hill Landing Usage by Residents**

- (a) Use of Eagle Hill Landing shall be made available to residents of the Town of Ipswich only.
  - (1) An Ipswich Resident is any person whose principal year-round domicile is within the Town of Ipswich. A person who owns and pays real estate or personal property taxes upon a summer residence or who rents residential property for a full season shall be considered a resident for purposes of this section.
- (b) No person shall park, place or store any motor vehicle, boat or trailer under his possession or control on said landing overnight.
- (c) Effective April 1, 2000, no person shall park a vehicle, either with or without a boat trailer attached thereto, within the easement area of the Eagle Hill Landing without having first obtained a permit from the Town for said purpose. Permits shall be issued each year and shall be issuable to Ipswich residents only. The permit year shall run from

April 1 to March 31 of the next year. The fee for an annual permit shall be \$35.00. Each Ipswich resident commercial shellfish licensee shall receive an annual Eagle Hill Landing parking permit with his/her commercial shellfish license for no additional charge above the rate for the commercial shellfish license. [1/13/2000]

- (d) Notwithstanding the enforcement and penalties provided elsewhere in the General By-Laws of the Town of Ipswich and the provisions of the Massachusetts General Laws, any person who violates subsections (a), (b), and/or (c) may be additionally subjected to the removal of said motor vehicle, boat or trailer by towing under the direction of the Chief of Police of the Town of Ipswich or his designee. [Adopted 5/13/96]

### **Section 12. Parking Permitted for Compact Cars Only**

No person shall park a vehicle in any space designated by these Traffic Rules and Regulations as a Compact Parking Space unless said vehicle is a compact automobile. The following spaces are designated as Compact Parking Spaces:

- (a) Market Street - westerly side, beginning at a point forty-three (43) feet south of the intersection of Central Street and Market Street, thence southerly for a distance of eleven (11) feet [Adopted 4/13/98]

### **Section 13. Parking Permitted By Vehicles With Attached Trailers Only**

Upon the following streets or highways or parts thereof, parking of a vehicle without a trailer attached thereto or the parking of an unattached trailer is prohibited:

- (a) Town Wharf northerly side beginning at its intersection with Agawam Avenue and thence westerly for a distance of two hundred ninety-seven (297) feet, from the period May 1 through October 15.
- (b) Town Wharf southerly side beginning at its intersection with Agawam Avenue and thence westerly for a distance of seventy-two (72) feet, from the period May 1 through October 15 [Adopted 4/26/99]

### **Section 14. Fire Lane (Reference to 527 CMR 25.05)**

No person shall park any vehicle which will impede suitable areas for the stationing of fire apparatus for extinguishment purposes, rescue, and evacuation of buildings in the following locations:

- (a) Access road - southeasterly side, starting at the handicap ramp, passing in front of the Performing Arts Center, southeasterly for four hundred twenty (420) feet to the loading dock
- (b) Access road - northwesterly side starting at the fire hydrant, southwesterly for a distance of four hundred fifty-two (452) feet to the corner of the parking area
- (c) Access road - northerly side adjacent to Middle School/High School 'A' Building, from the four-way intersection to School Street, for a distance of one hundred eighty-seven

- (187) feet
- (d) School Street - westerly side, from the handicap ramp at School Street and the access road for a distance of three hundred fifty-seven (357) feet, southerly to the handicap ramp at the southeasterly corner of Middle School/High School 'B' Building
  - (e) At the one-way road which begins at the front of the Performing Arts Center at the handicap ramp, easterly passing the Middle School main entrance for a distance of three hundred twenty-three (323) feet to the four-way intersection at the northwest corner of Middle School/High School 'A' Building
  - (f) Middle School/High School 'B' Building - southeasterly corner at the handicap ramp, westerly passing the High School main entrance, for a distance of two hundred fifty (250) feet
  - (g) Winthrop School front - southerly corner at the handicap parking space, northwesterly for a distance of one hundred thirty-eight (138) feet
  - (h) Doyon School southwesterly corner, northerly at the front of the building to the northwesterly corner, for a distance of two hundred ninety (290) feet

[Section 14 adopted effective 9/13/01]

- (i) Town Hall westerly parking lot – beginning at the cul-de-sac on the southerly end of the lot easterly around the south end of the Town Hall then turning northerly for a distance of three hundred sixty-five (365) feet, continuing northerly along the easterly side of the drive adjacent to the Annex Building for a distance of ninety-five (95) feet
- (j) Town Hall easterly parking lot – westerly side beginning at Green Street for a distance of ninety-four (94) feet

[Subsections (i) and (j) adopted effective 1/10/02]

### **Section 15. Parking Restricted in Certain Off-Street Municipal Parking Areas**

No person shall allow, permit, or suffer any vehicle registered in his/her name to stand or park in any space designated by these Traffic Rules and Regulations in violation of the following:

- (a) Adjacent to Elm Street- southerly side, beginning at a point seventy (70) feet easterly from the intersection of Elm Street and South Main Street, thence easterly for a distance of forty-three (43) feet, reserved for the Trial Court of Massachusetts staff during normal business hours, Monday through Friday

[Section 15 adopted effective 1/10/02]

### **Section 16. Designated Tow Zones**

Notwithstanding the enforcement and penalties provided elsewhere in the General Bylaws of the Town of Ipswich and the provisions of Massachusetts General Laws, the following areas are designated as Tow Zones, and whoever violates said restrictions may be subjected to the removal of said motor vehicle or trailer by towing under the direction of the Chief of Police or his/her designee.

- (a) Argilla Road from its intersection with Northgate Road to its terminus as the entrance to Crane Beach
- (b) Little Neck Road westerly side, from its intersection with Bayview Road, for a distance of one thousand fifty-six (1,056) feet to its terminus at Little Neck entrance
- (c) North Main Street middle branch, southeasterly side, beginning at its intersection with South Main Street and thence northerly for a distance of fifty-six (56) feet
- (d) Any area designated as a handicap parking zone.

[Section 16 (a) through (d) adopted effective 8/28/03]

- (e) Winthrop School parking, all areas, for nonschool business from Monday through Friday during the hours of 6:00 AM to 8:00 PM, starting September 1<sup>st</sup> and ending June 30<sup>th</sup> of each year [Adopted effective 8/11/05]
- (f) SCOFFLAW towing – any singular vehicle that has 4 or more unpaid Ipswich parking tickets will be placed on a SCOFFLAW list maintained by the Ipswich Parking Clerk and Ipswich Police Department. After receiving notification that a vehicle has 4 or more unpaid and overdue parking tickets, the Ipswich Police Department will mail a certified letter to the vehicle’s registered owner informing them of the need to pay the unpaid and overdue parking tickets or file a parking ticket appeal with the Parking Clerk within twenty-one (21) days. If, after twenty-one (21) days, the parking tickets are still unpaid, the vehicle’s registration will be placed onto a local hotlist and if found parked in a public parking space within the town, it will be subject to being towed.

Vehicles will only be subject to towing during normal Town Hall business hours (non-holiday weekdays) after the status of the unpaid parking tickets are validated with the Parking Clerk. Vehicles would be released after either paying the parking tickets in person at town hall or online (<https://www.kelleyryan.com/epay/>).

Once the parking tickets have been paid, proof of payment would be required to be brought to the Ipswich Police Department to obtain a tow release form. Towed vehicles would be subject to any applicable towing fees and storage fees as permitted by M.G.L. Chapter 159B, Sec. 6B and 220.CMR.272 Rates for the Towing of Motor Vehicles from any Ipswich Police approved tow companies.

### **Section 17. Parking Restricted in the Hammatt Street Parking Lot**

No person shall allow, permit, or suffer any vehicle registered in his/her name to stand or park in any municipal space in the Hammatt Street Parking Lot in violation of the following:

- (a) On the westerly side of its access corridor from its intersection with Hammatt Street, thence southerly for a distance of ninety-seven (97) feet
- (b) On the easterly side of its access corridor from its intersection with Hammatt Street, thence southerly for a distance of ninety-seven (97) feet
- (c) From the period 12:00 AM to 7:00 AM without a permit issued by the Board of Selectmen with the following exceptions:

- (1) On the first and third Tuesday of each month from the period beginning April 15 and ending November 15, no parking shall be allowed in those areas westerly of the entrance corridor from Hammatt Street to allow for maintenance and cleaning
  - (2) On the second and fourth Tuesday of each month from the period beginning April 15 and ending November 15, no parking shall be allowed in those areas easterly of the entrance corridor from Hammatt Street for the purposes of maintenance and cleaning
  - (3) During snow events that occur on even numbered days, no parking shall be allowed in those areas easterly of the entrance corridor from Hammatt Street to allow for plowing and snow removal
  - (4) During snow events that occur on odd numbered days, no parking shall be allowed in those areas westerly of the entrance corridor from Hammatt Street for the purpose of plowing and snow removal
- (d) From the period 7:00 AM to 7:00 PM for a period of time longer than three (3) hours in the following areas:
- (1) Beginning at a point ninety-two (92) feet southerly of its intersection with Hammatt Street, thence southerly for a distance of twenty-two (22) feet, thence easterly for a distance of fifty-four (54) feet
  - (2) Beginning at a point one hundred forty-three (143) feet southerly of its intersection with Hammatt Street, thence southerly for a distance of forty (40) feet, thence easterly for a distance of one hundred six (106) feet, thence southerly for a distance of twenty (20) feet, thence easterly for a distance of twelve (12) feet [Amended effective 8/11/05]
  - (3) Beginning at a point two hundred two (202) feet southerly of its intersection with Hammatt Street, thence southerly for a distance of twenty (20) feet, thence easterly for a distance of seventy-seven (77) feet [Amended effective 8/11/05]
  - (4) Beginning at a point one hundred fifty-four (154) feet southerly of its intersection with Hammatt Street, thence westerly for a distance of one hundred eighty-three (183) feet, thence westerly for a distance of forty-one (41) feet, thence southerly for a distance of seventy three (73) feet. [Adopted 11/04/04]



**Section 18. Parking of Heavy Commercial Vehicles**

- (a) The overnight parking of heavy commercial vehicles having a carrying capacity of more than two and one-half (2 ½) tons are hereby restricted on street or parts thereof located within the following Zoning districts:
  - (1) Rural Residential A, B, & C
  - (2) In-town Residential [Adopted 11/7/2011]
  
- (b) Exemptions: Part (a) of this section shall not apply to heavy commercial vehicles used in connection with the construction, maintenance, and repair of said streets or public utilities therein; or to Federal, State, Municipal, or public service corporation-owned vehicles. [Adopted 11/7/2011]

**Section 19. Resident Only Parking**

- (a) Between the hours of 6:00 a.m. and 6:00 p.m., Monday through Friday, use of Peatfield St (from Kimball Street to the Ipswich River), First St, Second St, Fourth St, Fifth St and Sixth St shall be limited to vehicles registered in the name of an Ipswich resident, the principal address of which and the registration address of which are located in Ipswich, as evidence by display upon the vehicle of a Solid Waste Transfer Station sticker or a Crane Beach sticker issued by the Town of Ipswich [07/15/19].

**ARTICLE VI**

**ONE-WAY STREETS**

Upon the following streets, or parts of streets, vehicular traffic shall move only in the direction indicated below:

- (a) Elm Street - easterly from South Main Street to County Street
- (b) North Main Street (westerly branch) - southerly from the southerly intersection of Meetinghouse Green to the intersection of Central Street
- (c) North Main Street (easterly branch) - southerly from North Main Street to South Main Street
- (d) Summer Street - westerly from North Main Street to County Street
- (e) Congress Street - northerly from Topsfield Road to Mount Pleasant Avenue
- (f) Travelled Way - westerly beginning at the eastern edge of the Town of Ipswich Lighthouse/Beach property, thence westerly to the eastern end of Argilla Road
- (g) North Main Street (central branch) - northerly for a distance of one hundred three (103) feet past the triangular plot of land containing the Soldier's Monument
- (h) Cottage Street - northerly from Washington Street to Brown Street
- (i) Wildes Court - southerly from Central Street to the municipal parking lot
- (j) South Village Green - southerly from South Main Street to County Road
- (k) Town Wharf - easterly from Water Street to Agawam Avenue during the period May 15th to October 1st each year [Adopted May 17, 1990]
- (l) Agawam Avenue - northerly from its intersection with the easterly end of the Town Wharf to its intersection with East Street for vehicles pulling trailers, for the period May 15th to October 1st of each year [Adopted May 17, 1990]
- (m) From the handicap ram in front of the Performing Arts Center passing easterly for a distance of three hundred twenty-three (323) feet to the corner of Middle School/High School 'A' Building at the four-way intersection [Adopted September 13, 2001]
- (n) At Linebrook Road, for a distance of one hundred (150) feet southerly to the drainage grate at the front of the Doyon School; thence southerly for a distance of four hundred (400) feet to the 'Do Not Enter' signs at the end of the parking lot [Adopted September 13, 2001]
- (o) At Central Street, for a distance of four hundred fifty (450) feet northeasterly to the handicap parking spaces; thence northwesterly for a distance of four hundred eighty-five (485) feet passing the front of the Winthrop School to Central Street [Adopted September 13, 2001]
- (p) At the rear of the fire station southerly from the driveway of the Winthrop School to Manning Street [Adopted effective August 28, 2003]
- (q) Lafayette Road northerly from its intersection with Wayne Avenue to its intersection with Prescott Street on each Sunday from 8:00 AM to 1:00 PM

- (r) Liberty Street northerly from Washington Street to Central Street. [Adopted effective 05/05/24/10]

**ARTICLE VII**

**OPERATION OF VEHICLES**

**Section 1. Overtake Only When There Is A Space Ahead**

The driver of a vehicle shall not overtake and pass a vehicle proceeding in the same direction unless there is a clear and unobstructed view of a minimum of four hundred (400) feet.

**Section 2. Obstructing Traffic**

- (a) No person shall drive in such a manner as to obstruct unnecessarily the normal movement of traffic upon any street or highway. Officers are hereby authorized to require any driver who fails to comply with this section to drive to the side of the roadway and wait until such traffic as has been delayed has passed.
- (b) No driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk and on the right half of the roadway to accommodate the vehicle he is operating without obstructing the passage of other vehicles or pedestrians, notwithstanding any traffic control signal indication to proceed.

**Section 3. Emerging From Alley or Private Driveway**

The operator of a vehicle emerging from an alley, driveway, or a garage shall stop such vehicle immediately prior to driving onto a sidewalk or onto the sidewalk area extending across the alleyway or driveway.

**Section 4. Stop Signs**

- (a) Every driver of a vehicle, street car, or other conveyance, approaching an intersecting way at which there exists, facing him, an official sign, authorized by the Board of Selectmen, (the said sign having apart from this regulation the written approval under Chapter 89, Section 9, of the General Laws from the Department of Public Works of the Commonwealth of Massachusetts) and bearing the word "Stop" shall before entering and proceeding through the intersection bring such vehicle, street car or other conveyance to a complete stop on such line as may be clearly marked, or, if there is no line so marked, on a place between the said sign and the nearer line of the street intersection. After stopping, the driver must yield to oncoming traffic in the intersection.
- (b) In the case of a line of two (2) or more vehicles in a group approaching a "Stop" sign, the drivers of the second and subsequent vehicles in any group each shall be required to stop at said designated line or place or in the immediate vicinity.

- (c) This regulation shall not apply when the traffic is otherwise directed by a police officer or by any other lawful traffic regulation sign, signal or device, to any through-way established by this Town.
- (d) Stop signs authorized pursuant to subsection (a) of this Section, shall be placed and maintained at the following locations:

**Section 5. Yield Right of Way**

No person shall enter an intersection properly signed "Yield" unless and until he/she has slowed and determined there is adequate space in the same lane and direction of travel to enter the intersection without causing other traffic within the intersection to reduce speed. A rear end collision shall be considered prima facia evidence of the failure of a person to properly yield the right of way. In accordance with the provisions of Chapter 89, Section 9, of the General Laws, the following street(s) are designated as yield streets, at the intersections and in the direction indicated: [Amended May 15, 1986]

**Section 6. Operation of Heavy Commercial Vehicles**

- (a) The use and operation of heavy commercial vehicles having a carrying capacity of more than two and one-half (2 1/2) tons are hereby restricted on the following named streets or parts thereof and in the manner outlined and during the period of time set forth.
- (b) Exemptions: Part (a) of this section shall not apply to heavy commercial vehicles or farming and agricultural vehicles going to or coming from places upon said streets for the purpose of making deliveries of goods, materials, or merchandise to or similar collections from abutting land or buildings or adjoining streets or ways to which access cannot otherwise be gained; or to vehicles used in connection with the construction, maintenance, and repair of said streets or public utilities therein; or to Federal, State, Municipal, or public service corporation-owned vehicles.[Amended 12/02/19]
- (c) The provisions of this section shall apply only when there are sufficient standard signs erected notifying operators of the restriction.

**Section 7. Operation of Heavy Commercial Vehicles - Weight Limits on Certain Bridges**

**Section 8. Operation of Heavy Commercial Vehicles - Weight Limits on Certain Streets and Highways**

**ARTICLE VIII**

**ADVERTISING SIGNS, DISPLAY AND STORAGE OF MATERIALS IN  
STREETS**

**Section 1. Using Vehicles for Sole Purpose of Displaying Advertising Prohibited**

No person shall operate or park a vehicle on any street or highway for the sole purpose of displaying advertising signs.

**Section 2. Advertising Signs On Sidewalks or Streets Must Have Permits**

No person shall erect or cause to be erected upon or above any sidewalk, street, or highway any advertising sign or device which projects into or over the sidewalk, street or highway more than six (6) inches, unless a permit authorizing erection of such sign or device has been issued by the Board of Selectmen and is in effect. After five days' notice, illegal advertising signs or devices may be removed by or under the direction of a police officer and at the expense of the owner.

**Section 3. Placing of Structure or Property in Streets Prohibited**

- (a) No person shall place, erect, or cause to be placed or erected within any sidewalk, street or highway any fixture or structure unless a permit, issued by the Selectmen, in the case of town ways, or the Department of Public Works, Commonwealth of Massachusetts, in the case of state highways, authorizing such placing or erection has been granted and is in effect.
- (b) No person, other than one employed directly or indirectly by the Town of Ipswich, or by the Commonwealth of Massachusetts, while in the performance of necessary public duties, shall at any time, deposit or leave in any sidewalk, street or highway, any article, material or merchandise, or park a vehicle or cart in any sidewalk, street or highway for the purpose of displaying merchandise, unless a permit issued by the Board of Selectmen in the case of town ways, or by the Department of Public Works in the case of state highways, authorizing the use of the sidewalk, street or highway has been granted and is in effect, except as may be necessary for the reasonable and expeditious loading or unloading of any such article, material, merchandise, cart or vehicle, provided, however, that such property shall never be left so as to obstruct the free passage of pedestrians or vehicular travel.

- (c) Any such fixture, structure or property as referred to in this section which has been erected, deposited or left illegally in any street, highway or sidewalk may be moved by or under the direction of a police officer and at the owner's expense.

**Section 4. Deposit, Bond or Insurance Policy May Be Required For Privilege of Using Street For a Special Purpose**

The Board or officer issuing permits for use of sidewalks, streets, or highways as are described in the two previous Sections may, in its or his/her discretion, when occasion justifies, demand a suitable cash deposit, surety bond or insurance indemnity policy to save the Town or the Commonwealth of Massachusetts harmless from all liability of any nature whatsoever caused directly or indirectly by such use of the sidewalk, street or highway.

**ARTICLE IX**

**ACCIDENT REPORTS, RESPONSIBILITY, AND PENALTIES**

**Section 1. Drivers Must Report Accidents**

The driver of any vehicle involved in an accident resulting in the injury or death of any person or property damage in excess of one thousand dollars (\$1,000) shall, within five (5) days make a full and complete report in writing of such accident to the police headquarters in this Town. A driver who has been incapacitated as a result of such accident, and to such extent as to make reporting impossible or unfavorable to his recovery, shall not be required to report such accident until he has sufficiently recovered to be able to do so. The report shall be made on a form furnished by the Police Department, copies of which shall be available at the Police Station. Compliance with this section, however, shall not relieve such driver from the additional responsibility of reporting to the Registrar of Motor Vehicles any accident as required by State Law.

**Section 2. Penalties**

(a) Any person violating any provision of any rule, regulation, or order regulating the parking of motor vehicles made by anybody authorized to make the same shall be dealt with as provided in Section 20A1/2 of Chapter 90 of the General Laws, as amended in accordance with the following fine schedule:

  - (xiii) Violation of Waterfront Parking Zone Law
  - (xiv) Violation of Fire Station Parking Zone Law
  - (xv) Violation of Bridge Parking Zone Law
  - (xvi) Double Parking

- (3) Each fine for a violation, if not paid within twenty-one (21) days of issuance, shall be assessed an additional five dollars (\$5.00).
- (4) Each fine for a violation, if not paid within twenty-one (21) days of issuance which has been assessed an additional five dollars (\$5.00).and still remains unpaid, shall be assessed a second five dollars (\$5.00) or expenses associated with the reporting of the violation to the Registrar of Motor Vehicles for license and registration revocation.
- (b) Any person violating any provision of any rule, regulation, or order regulating the parking of motor vehicles by anybody authorized to make the same shall be dealt with as provided in Sections 21 and 22A of Chapter 40 of the General Laws, as amended in accordance with the following fine schedule:

- (c) Any person violating any of the rules and regulations applicable to State Highways made by the Department of Public Works, Commonwealth of Massachusetts, under authority of Chapter 85, Section 2, of the General Laws, shall be subject to the Penalty provided in said rules and regulations.
- (d) Any person convicted of a violation of any other rule, regulation, or order made hereunder, except as otherwise provided, shall be punished by a fine not exceeding fifty dollars (\$50.00).for each offense.

**ARTICLE X**

**REPEAL**

**Section 1. Intent**

- (a) These rules and regulations are adopted with the intent that each of them shall have force and effect separately and independently of every other except insofar as by express reference or necessary implication any rule or any part of a rule is made dependent upon another rule or regulation or part thereof.
- (b) The provisions of these rules and regulations, provided they are the same as those existing rules, orders or regulations heretofore made by the Selectmen of The Town of Ipswich relative to or in connection with official signs, lights, markings, signal systems or devices, shall be construed as a continuation thereof, but all other existing rules, orders and regulations so made for the regulation of vehicles are hereby expressly repealed. This repeal, however, shall not affect any punishment or penalty imposed or any complaint or prosecution pending at the time of the passage hereof for an offense committed under any of the said rules, orders, or regulations hereby repealed.

**Section 2. Effect of Regulations**

If any section, subsection, sentence, clause or phrase of these rules and regulations is for any reason unlawful or unconstitutional, such decision shall not affect the validity of the remaining portion of these rules and regulations. The Board of Selectmen hereby declares that it would have passed these regulations and each section, subsection, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unlawful or unconstitutional.
